Article 2

SCOPE OF COOPERATION

Article 3

FINANCIAL ARRANGEMENT

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Maharaja Manindra Chandra College and Vivekananda College
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5


MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the Online mode if required.


Article 6

DURATION AND TERMINATION

- 3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six(6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

AMENDMENT


- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.




