

Article 2

**SCOPE OF COOPERATION**

Article 4

**LOCATION OF ACTIVITIES**

1. The Parties agree to implement the programmes stated in Article 2 at Maharaja Manindra Chandra College and Women's College, Calcutta
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5


**MODE OF CONDUCTING THE PROGRAMMES**

Article 6


**DURATION AND TERMINATION**

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of five(5) years and may be extended for another period of five(5) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six(6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.
