Terms and Conditions:

Responsibilities:

- a) Maharaja Manindra Chandra College and Empathy Educare—shall designate respective representatives who will liaison and be responsible for coordinating activities under this MoU.

- c) Each institution will provide necessary resources and support for collaborative activities as mutually agreed upon from time to time.
- d) There will be a regular joint meeting between the 2 parties, as their jointly decided venue and time, based on their jointly decided agenda to make progress and evaluate the actions necessary w.r.t this MoU

Duration:

This MoU shall be effective from the date of joint signature by both parties 1 & 2 and shall remain in effect for 5 years from that date, unless terminated earlier by mutual agreement or as provided herein.

Termination:

Either party may terminate this MoU by providing written notice to the other party, 30 days in advance.

Amendments:

Any amendments to this MoU shall be made in writing, signed by authorized representatives of both parties and 1 original copy each to be retained by both parties.

Confidentiality:

The parties shall maintain the confidentiality of any proprietary information shared during the collaboration.

Financial arrangement:

Any financial support or cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

Settlement of Disputes:

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the 2 Parties.
