AGREEMENT/ MOU

THIS AGREEMENT (hereinafter referred to as the "Agreement") is made on the 4th_day of _April__, Two Thousand and Twenty-Four (2024) and entered into:

BSE Institute Ltd and Maharaja Manindra Chandra College shall hereinafter be also jointly referred to as the "Parties" and severally as the "Party".

AND WHEREAS the parties of the first and second part have appreciated each other's objectives in promoting excellence, inter alia, in education in common area of interest and are desirous of entering into an agreement for mutual benefit. They wish to come together for delivery and dissemination of vocational education in the area of BFSI (Banking, Financial Services and Insurance).

Now, therefore, in consideration of the foregoing and the mutual covenants set forth herein, the Parties hereto agree as follows:

2.1 Batch Size:

4.5 Infrastructure

Maharaja Manindra Chandra College shall provide all the infrastructural facility for conducting the course in Maharaja Manindra Chandra College campus. 4.6 Candidate details

4.7 Faculty Contains

Maharaja Manindra Chandra College shall not use the name or logo of BSE Institute / BSE re Williout their written consent. It is agreed between Maharaja Manindra Chandra College and BSE Institute that neither party during the course of this agreement shall desire nor intend to transfer any intellectual property rights whatsoever with respect to any information that is proprietary. Maharaja Manindra Chandra College may use the logo and name of BSE Institute for the purposes of this course only by taking prior written permission from BSE Institute for every such use.

7. TERMINATION

Breach of this agreement by either of the parties shall terminate this agreement. 8. DISPUTE RESOLUTION

If any dispute or difference of any kind whatsoever may arise between the Parties in connection with or arising out of this agreement, BSE Institute and Maharaja Manindra Chandra College shall attempt for a period of 30 days after receipt of notice by the other Party of the existence of a dispute to settle such dispute in the first instance by mutual discussions between the Parties. All disputes, differences or questions arising out of this agreement including the interpretation of the terms herein or in regard to the obligations, failure or breach of any terms thereof by either of the party under this agreement which have not been mutually settled as per the provisions of this clause shall be referred to arbitration under the provisions of the Arbitration and Conciliation Act, 1996. The Parties shall mutually appoint an arbitrator. The place of arbitration shall be mutually decided between the parties hereto. The language for Arbitration shall be English. The provisions of this clause shall survive the termination of this Agreement.

9. GOVERNING LAW/ JURISDICTION:

The laws of India shall govern this Agreement. Both parties irrevocably submit to the exclusive jurisdiction of the Courts in Mumbai, for any action or proceeding regarding this Agreement.
