

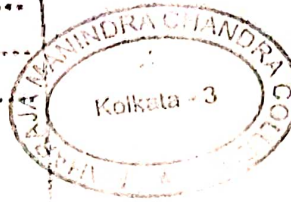

About the Institutions

On the 15 July 1941, a great expectation of the people living North of Beadon Street was fulfilled with the foundation of **Maharaja Manindra Chandra College at 20, Ramkanto Bose Street, Kolkata-700003**. It had been possible due to the drive and initiative of some spirit of **Dr. Panchanan Neogi I.E.S (Retd.)**, a well-known educationist of the time and the benevolence of Maharaja Sris Chandra Nandi of Cossimbazar. The genesis of the college may be traced to a public meeting held on December 15, 1940, at 44/A, New Shyambazar Street. A resolution was adopted in that meeting to the effect that an Arts, Science and commerce college be opened in memory of the illustrious Maharaja Manindra Chandra Nandi of Cossimbazar at 20, Ramakanto Bose Street, Kolkata. His son Hon'ble Maharaja Sris Chandra Nandi kindly consented to hand over the premises to the proposed Governing Body of the College. The College, in course of time, under the able stewardship of its illustrious Principals, assumed the status of one of the premier colleges of Kolkata and has been accredited by NAAC in the year 2011 with grade 'B'. The College has celebrated its Platinum Jubilee in the Session 2015-16.

Article 3

FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

FMBM will charge nominal registration fees from the participants which will vary from programme to programme.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Maharaja Manindra Chandra College and any other appropriate venue relevant to the programme or if necessary it can be done online.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the Online mode if required.

Article 6

DURATION AND TERMINATION

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for five (5) years and may be extended for another 5 years by the mutual written consent of the Parties.
- 3) There may be modification or alteration in the type of cooperative programmes after one (1) year with mutual consent of the Parties
- 4) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
- 5) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 7

AMENDMENT

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revisions shall come into force on the date as may be determined by the Parties.
